

For large data sets, Trina and her team create a directory of a piece of media, cull down the directory list, stage and copy the hard drive using SafeCopy, and conclude by processing copied data into Dorsey's review platform. "Typically, I tell clients that staging and copying occurs at a rate of 8GB/hour, but if the collection contains larger files instead of several small files, SafeCopy copies at a much faster rate. The time frame can be hard to predict due to varied environment controls," Trina explained.
